



Chelagat got involved in a road accident in 2006 and suffered multiple injuries including fractures. She was also diagnosed with a spinal problem which she nursed but kept recurring. She became wheelchair-bound.

Philomena Chelagat Muai(January 29, 1949- July 6, 2013) was a prominent female Kenyan politician and human rights defender known for her bold utterances in and outside the Parliament of Kenya. Popularly known as 'Chelagat Mutai', she started out as a vocal student activist and journalist, later joining elective politics early in her life and becoming a fierce critic of the Kenya government. She became an Amnesty International prisoner of conscience when the administration of President Jomo Kenyatta clamped down on dissent and threw her in jail. She was eventually exiled from Kenya joining a cast of foreign-based Kenyan dissidents fleeing the repressive regimes of Mzee Jomo Kenyatta and Daniel Moi. In October 1974, at the age of 25, she became the youngest person elected to the Kenyan Parliament, defeating a cast of 11 male contestants in a tight race for the Eldoret North

She quickly joined Kenya's leftist politics, becoming a fierce critic of the Kenyatta government, and was imprisoned as a result. Soon after her incarceration, she returned to politics winning back the seat she had lost. She would not last long and would be exiled from Kenya, fleeing what she believed to be another round of politically motivated incarceration. She spent several years in exile in Tanzania. She championed the inclusion of women in Kenyan politics and society, and as a lifelong activist for good governance.

Early life

Chelagat Mutai was born on January 29, 1949, in Terige Sublocation, Lessos Location in Nandi County. She was the last-born daughter of the Antony Kimutai araap Kogo a prominent local farmer and Paulina Kogo.

Catholic and on February 6, she joined politics. Her old-1949, she was baptized at the St. Joseph's Catholic Church Chepterit by the presiding priest Fr. John Daley.

She was given the name 'Filomena' which in later life she spelt Philomena. Chelagat was born into a politically active family. Her father had been at one time a member of the Nandi Local Native Council (LNC) council at Kapsabet. Her uncle Michael Kibet Rongoei had served in the Rift Valley Regional Assembly and also at the Sirikwa County Council as a councillor. Her maternal uncle William Morogo Saina would later become the Eldoret North member of Parliament and whom

Her family was strongly she would succeed when er brother Eng Jan Mutai (1945-2020) was a prominent public servant who was at one time the Managing Director of the giant Kenya Posts & Telecommunications Corporation (KPTC).

Life at the University Chelagat became one of the first Kalenjin women to be admitted to the newly-established University of Nairobi. She reported at the main campus on September 1970 to begin her degree program. Prior to that, she had secured a temporary job at the leading newspaper in Nairobi, The East African Standard, as a reporter. She conducted her reportage

mainly in Nairobi. She re-

signed just prior to joining the university after only six months on the job. At that point, there were very few women on campus and even fewer from her Kalenjin ethnic community. In spite of her then 'minority' status, her campus presence was quite prominent as she had a natural gift of public speaking delivering fiery speeches during kamukunjis or informal student meetings held to address emerging issues affecting students.

The Constitution of Kenya 2010 bears the voices of many social and political activists over the years. It bears Chelagat's voice too.

New York City police commissioner resigns



ew York City Police Commissioner Edward Caban resigned Thursday, one week after it emerged that his phone was seized as part of a federal investigation that touched several members of Mayor Eric


Adams' inner circle.

Caban, who had been in charge of the nation's largest police department for about 15 months, said in an email to staff that he made the decision to resign after the "news around recent developments" had "created a distraction for our department."

"I am unwilling to let my attention be on anything other than our important work, or the safety of the men and women of the NYPD," he added in the email obtained by The Associated Press.

At a news conference Thursday, Adams praised Caban for "making our city safer" and said he had named Tom Donlon, a retired FBI official, as the interim police commissioner.

Donlon previously served as the chief of the FBI's National Threat Center and once led the Office of Homeland Security in New York, before starting his own security firm in 2020. He helped lead the investigation into the 1993 World Trade Center bombing and investigated the 1998 U.S. Embassy bombings and USS Cole bombing.



ormer President Donald Trump said in a social media post on Thursday that he will not debate Vice President Kamala Harris a second time before Election Day.

"THERE WILL BE NO THIRD DEBATE!" Trump wrote on Truth Social in reference to his first debate against President Biden in late June and a second debate against Harris this

In the post, Trump maintained that "pol-Is clearly show" that he won the debate, though he did not provide any evidence to back up his claim.

Three polls taken immediately after the date found that Harris outperformed Trump. CNN/SSRS showed Harris beating Trump by a margin of 63%-37%, SoCal Strategies/On Point Politics/Red Eagle Politics had Harris over Trump by 53%-34% and YouGov found that Harris bested Trump by a margin of 54%-31%. Two other post-debate polls released Thursday showed Harris building her national lead over Trump. A national Morning Consult poll found Harris leading Trump by five points, a three-point bump following Tuesday's debate. A Reuters/ Ipsos poll also found Harris with a five-point lead.

Moments after Trump announced his decision to forego another debate with Harris, the vice president took the stage at a campaign rally in Charlotte, N.C., and proclaimed "we owe it to the voters to have another debate!"

On Tuesday, Harris's campaign called for a second debate between the two candidates to be held in October.

Vice President Harris is ready for a second debate. Is Donald Trump?" Harris



campaign chair Jen O'Malley Dillon said in a statement Tuesday night.

Following the first debate, Minnesota Gov. Tim Walz was asked by MSNBC's Rachel Maddow whether his running mate should debate Trump again.

"Look, I don't want to speak for her, but I would be there encouraging her to do it every day," Walz responded, and there is data to back up his confidence.

n Wednesday, Trump sought to cast himself as the winner of the debate. "The first thing they did is ask for a debate because when a fighter loses, he says 'I want a rematch," Trump said during a Wednesday morning interview on Fox & Friends.

Trump repeated that message in a post on Truth Social.

"In the World of Boxing or UFC, when a Fighter gets beaten or knocked out, they get up and scream, 'I DEMAND A RE-MATCH, I DEMAND A REMATCH!' Well, it's no different with a Debate,"



he wrote. "She was beaten badly last night. Every Poll has us WINNING, in one case, 92-8, so why would I do a Rematch?"

It's possible that the former president may change his mind in the coming days and weeks, but Thursday's statement represented the first time he had definitively turned down the Harris campaign's challenge.

Harris quickly responded to Trump, writing on X that the candidates "owe it to the voters to have another debate."

It looks like Tuesday night's presidential debate between Vice President Kamala Harris and former President Donald Trump may have been the final face-off of the 2024 election.

Hamas Leader, Other Militants To Face Charges

Other Hamas leaders facing charges include Marwan Issa, deputy leader of Hamas' armed wing in Gaza, who helped plan last year's attack and who Israel says was killed when its fighter jets struck an underground compound in central Gaza in March

he Justice Department announced criminal charges Tuesday against Hamas leader Yahya Sinwar and other senior militants in connection with the Oct. 7, 2023, rampage in Israel, mar-

king the first effort by American law enforcement to formally call out the masterminds of the attack.


The seven-count criminal complaint filed in federal court in New York City includes charges such as conspiracy to provide material support to a foreign terrorist organization resulting in death, conspiracy to murder U.S. nationals and conspiracy to finance terrorism. It also accuses Iran and Lebanon's Hezbollah of providing financial support, weapons, including rockets, and military supplies to Hamas for use in attacks.

The impact of the case may be mostly symbolic given that Sinwar is believed to be hiding in tunnels in Gaza and the Justice Department says three of the six defendants are believed now to be dead. But officials say additional actions are expected as part of a broader effort to target a militant group that the U.S. designated as a foreign terrorist organization in 1997 and that over the decades has been linked to a series of deadly attacks on Israel, including suicide bombings.

The complaint was originally filed under seal in February to give the U.S. time to try to take into custody then-Hamas leader Ismail Haniyeh and other defendants, but it was unsealed Tuesday after Haniyeh's death in July and other developments in the region lessened the need for secrecy, the Justice Department said.

"The charges unsealed today are just one

part of our effort to target every aspect of Hamas' operations," Attorney General Merrick Garland said in a video statement. "These actions will not be our last." The charges come as the White House says it is developing a new cease-fire and hostage deal proposal with its Egyptian and Qatari counterparts to try to bring about an agreement between Israel and Hamas to end the nearly 11-month war in

A U.S. official, who was not authorized to talk publicly about the case and spoke on condition of anonymity, told The Associated Press there was no reason to believe the charges would affect the ongoing ne-


National security spokesman John Kirby said the recent "executions" of six hostages, including one American, Hersh Goldberg-Polin, by Hamas underscore "the sense of urgency" in the talks.

"We are investigating Hersh's murder, and each and every one of the brutal murders of Americans, as acts of terrorism." Garland said in the statement. "We will continue to support the whole of government effort to bring the Americans still being held hostage home."

Sinwar was appointed the overall head of Hamas after the killing of Haniyeh in Iran and sits atop Israel's most-wanted list. He is believed to have spent most of the past 10 months living in tunnels under Gaza, and it is unclear how much contact he has with the outside world





endell Bontemps

During the early 1930s, African-American writers and intellectuals were discriminated against in Northern Alabama. Thirty miles from Huntsville in Decatur, the Scottsboro boys, nine African Americans, were charged with rape of two white women and being prosecuted in a case that became renowned for racial injustice.



rrna Wendell Bontemps was an American poet, novelist and librarian, and a noted member of the Harlem Renaissance. Early life

Bontemps was born

in 1902 in Alexandria, Louisiana, into a Louisiana Creole family. His ancestors included free people of color and French colonists. His father was a contractor and sometimes would take his son to construction sites. As the boy got older, his father would take him along to speak-easies at night that featured jazz.

His mother, Maria Carolina Pembroke, was a schoolteacher. The family was Catholic, and Bontemps was baptized at St. Francis Xavier Cathedral. They would later become Seventh-day Adventists.

When Bontemps was three years old, his family moved to Los Angeles, California, in the Great Migration of blacks out of the South and into cities of the North, Midwest and West. They settled in what became known as the Watts district. After attending public schools, Bontemps attended Pacific Union College in Angwin, California, where he graduated in 1923. He majored in English and minored in history, and he was also a member of the Omega Psi Phi fraternity.

Career

Following his graduation, Bontemps met and befriended the author Wallace Thurman, founder of Fire!! magazine, in his job at Los Angeles Post Office. Bontemps later traveled to New York City, where he settled and became part of the Harlem Renaissance.

In August 1924, at the age of 22, Bontemps published his first poem, "Hope" (originally called "A Record of the Darker Races"), in The Crisis, official magazine of the National Association for the Advancement of Colored People (NAACP). He depicted hope as an "empty bark" drifting meaninglessly with no purpose, referring to his confusion about his career. Bontemps, along with many other West Coast intellectuals, traveled to New York during the Harlem Renaissance.

After graduation, he moved to New York in 1924 to teach at the Harlem Academy (present-day Northeastern Academy) in New York City. While teaching, Bontemps continued to write and publish poetry. In both 1926 and 1927, he received the Alexander Pushkin Prize of Opportunity, an academic journal published by the Na-

tional Urban League. In 1926 he won the Crisis Poetry Prize.

In New York, Bontemps met other writers who became lifelong friends, including Countee Cullen, Langston Hughes, W. E. B. Du Bois, Zora Neale Hurston, James Weldon Johnson, Claude McKay and Jean Toomer. Hughes became a role model, collaborator, and dear friend to Bontemps.

During the early 1930s, African-American writers and intellectuals were discriminated against in Northern Alabama. Thirty miles from Huntsville in Decatur, the Scottsboro boys, nine African Americans, were charged with rape of two white women and being prosecuted in a case that became renowned for racial injustice.

During this time, Bontemps had many friends visit and stay with him while they came to Alabama to protest this trial. The school administration was worried about his many out-ofstate visitors.

In later years, Bontemps said that the

administration at Oakwood Junior College had demanded he burn many of his private books to demonstrate that he had given up radical politics. Bontemps refused to do so. He resigned from his teaching position and returned with his family to California in 1934.

In 1936 Bontemps published what is considered by some as his best work, Black Thunder. This novel explores a slave rebellion that took place in 1800 near Richmond, Virginia, led by Gabriel Prosser, an uneducated, enslaved field worker and coachman. It describes Prosser's attempt to conduct a slave army to raid an armory in Richmond, in order to defend themselves against any assailants. A fellow slave betrayed Prosser, causing the rebellion to be shut down. Prosser was captured by whites and lynched. In Bontemps' version, whites were compelled to admit that slaves were humans who had possibilities of a promising life.

Bontemps died aged 71 on June 4,

1973, at his home in Nashville, from a myocardial infarction (heart attack), while working on his collection of short fiction in The Old South (1973).

Bontemps is buried at Greenwood Cemetery in Nashville, Tennessee.

Through his librarianship and bibliographic work, Bontemps became a leading figure in establishing African-American literature as a legitimate object of study and preservation. His work as a poet, novelist, children's writer, editor, librarian and historian helped shape modern African-American literature, but it also had a tremendous influence on African-American culture.







Our Wings Of Glory

I was due to fly back to Kenya on 7th June 1982 when I learned that a red carpet awaited me at Jomo Kenyatta. Exile was my only option. In exile I did not give up.

he moment, organized by Kenyans, is special and very personal. I have received many honors and prizes from all over the world, in fact two days ago in Canada I received my 14th Honorary Doctorate from Oueens

my 14th Honorary Doctorate from Queens University. The other doctorates have come from some of the top Universities in Europe, America, and New Zealand. In Africa I have received three doctorates from universities in South Africa, Dar-es-Salaam and Kenya. But no such an honor has been accorded me by the University where, I along with others like Micere Mugo, Taban Lo Liyong, Owuor Anyumba, did so much to put Nairobi University on the global intellectual map.

We were the first Department in the world to call for the abolition of the English Department as then constituted and have it re-organised as a Department of Literature, with Africa at the center. And thus was born the afro-centric studies and also post-colonial theory.

Some of the graduates from our department would go on to become leading professors all over the world. Let me mention a few: Simon Gĩkandi who I call Prince of Princeton is currently one of the top Professors in America. James Ogunde, is one of the leading professors in South Africa. There are others like Kĩmani Njogu, Wanjikũ Kabira, and Gĩtahi Gĩtiti, too many to mention them all.

What is the secret of their success and global visibility? Firmly rooted in Kenya and Africa, they were able to fly to the stars.

In this category let me single out the late Henry Chakava. Chakava a fresh graduate of the Department of literature inherited the reins of the Kenya Branch of the British owned Heinemann Educational Publishers and in no time, turned it into a fully Kenyan owned and run company. He even changed its name to East Africa Education Publishers. Under his leadership the company became the leading African owned Publishing Company in Africa and the world. Talk of what self-confidence can do!

What was the reward I got from Kenya for inspiring Kenyans to global visibility while rooted in their own country? Mocked in Parliament, accused of abolishing Shakespeare (NOT TRUE) and replacing him with Marxists from the Caribbean like George Lamming and V S Naipaul. In 1978 I lost my job and I was banned from any teaching institution in Kenya.

But that was only the beginning of my saga with my beloved country. In 1977, four of us from the university of Nairobi, viz Ngũgĩ wa Mĩriĩ, Sultan Somjee, Kĩmani Gecau went work with the peasants and workers of Kamîrîthû, driven by our belief that real power, our power, comes from an awakened people. We called it Kamîrîthû Education and Cultural Center, and in Gîkũyũ, Mũciĩ wa Mũingĩ Mũgĩ, i.e. the Home Base of a people with an awakened consciousness. With the peasant farmers and workers in factories and in the tea plantations, we produced a play in Gîkũyũ language, Ngaahika Ndeenda, which drew thousands from all over Kenya. The day it was banned, buses from Kisumu, on their way to Kamîrîthû had to turn back in Nakuru.

Kamīrīthū would become an inspiration for people theater around the world. In Malaysia they even produced a news-magazine called; the Kamīrīthian. Kamīrīthū has been the subject of theater studies and doctoral dissertations around the world.

What was my reward from the Kenya government? Jomo Kenyatta placed me in Kamîtî Maximum Security prison for a year viz 1977-78

In prison I wrote the first ever novel in my mother tongue: Caitaani Mütharabainī/Devil on the Cross. I was driven by the same motivation and belief: Our languages can also produce great written literature to compete with the best in other languages including European languages.

The reward? The Moi Dictatorship tried to stop its publication by sending anonymous telephone threats to Henry Chakava, the publishers. In the end they sent assassins to abduct him. A passing car saved Chakava. But the assassins managed to cut off his finger and he had to have it surgically reconnected. But Henry Chakava went ahead and published Caitaani Mūtharaabainī as scheduled in 1981 (?). Later the same Moi dictatorship forced me into exile.

How?

In 1982 I went to England for the launch of my English translation of my Gĩkũyũ novel written in prison. The English title was Devil on the Cross. I was due to fly back to Kenya on 7th June 1982 when

I learned that a red carpet awaited me at Jomo Kenyatta. Exile was my only option. In exile I did not give up. I wanted to show that even in an English speaking environment, I could still write in Gĩkũyũ. And I did: two novels in fact: Matigari ma Njirũngi and Mũrogi wa Kagogo. Matigari was confiscated by the Moi regime. And eleven days after my arrival in Kenya after 23 years of exile to help launch my other Gĩkũyũ novel, Mũrogi wa Kagogo, assassins, armed with a gun, stormed my hotel room. My wife and I barely escaped with our lives.

But the regime would not stop there. Years later, I attended a Unicef conference in Harare, Zimbabwe, in support of the children of Mozambique, ravished by the RENAMO terrorist rebels directed by then apartheid regime in South Africa, to destabilize the FRELIMO government. On the way there I sat next to Harry Bellafonte, then an Ambassador of UNICEF. In the middle of a meeting in Harare, I was summoned to the offices of the Zimbabwe Intelligence. They had just stopped two armed police assassins, outside the door of my hotel. They did not want to alarm me. They wanted to assure me that the Zimbabwe Intelligence would keep a vigilant eye during my stay. I was not sure what to make of the story. But soon after, I learnt that the Moi regime had recalled the official Kenya delegation to the conference, I suppose, in protest at my presence.














BIDEN HIGHLIGHTS



President Joe Biden briefly donned a red "Trump 2024" hat during a visit to a Shanksville, Pennsylvania fire station, in what the White House described as a gesture of unity on the anniversary of the September 11 attacks.

"At the Shanksville Fire Station, @POTUS spoke about the country's bipartisan unity after 9/11 and said we needed to get back to that," White House senior deputy press secretary Andrew Bates posted on social media.

Bates said Biden gave a hat to a Trump supporter in the crowd as a friendly gesture. The supporter then asked Biden to put on a Trump cap in the name of bipartisanship, and the president went along, briefly wearing the red hat.

As a gesture, he gave a hat to a Trump supporter, who then suggested that, in the same spirit, POTUS should wear the Trump cap. He briefly put it on," Bates added.

he father of an 11-year-old Ohio who was killed last year when a minivan driven by a Haitian immigrant struck his

school bus said Tuesday that Donald Trump and JD Vance were "morally bankrupt politicians" who were using his dead son as a political tool.

Nathan Clark, of Springfield, denounced the Republican presidential ticket and asked Trump and Vance to apologize in an impassioned speech before the City Commission after Vance, the Republican nominee for vice president, mentioned the death of Clark's son Aiden as a reason to oppose Haitian immigration.



"Using Aiden as a political tool is, to say the least, reprehensible for any political purpose," Clark said during the commission's public comment period, according to a livestream of the meeting.

"This needs to stop now," he added. "I will listen to them one more time to hear their apologies."

Asked for comment on Clark's statement, Luke Schroeder, a

spokesperson for Vance, said that Vice President Kamala Harris should apologize to people who are victims of crime allegedly committed by immigrants - some of whom have blamed the Biden administration and testified before Congress.

"They hold her and her open borders policies accountable for the deaths of their children," Schroeder said in an email.

"The Clark family is in Senator Vance's prayers," he said.

Campaign representatives for Trump did not immediately respond to requests for comment late Tuesday, as Trump was preparing to debate his Democratic opponent, Harris.

Earlier Tuesday, the Trump-Vance campaign thrust the 11-year-old boy and his family into the nation's political spotlight. Vance alluded to Aiden in a post on X, writing that "a child was murdered by a Haitian migrant." On Monday, an X account used by the Trump campaign posted a tweet about Aiden.

OUR WINGS OF GLORY

Our languages are our wings to glory. Let us root ourselves in them and Africa will fly.

hat was my crime?

I was trying to show that rooted in our languages and belief in the power of the

Kenya working class and the small farmer, ie the Wanjikũ of Kenya and Africa, we can break any barriers set against our development. There is no height we cannot reach.

Trying to beak barriers has been the constant theme in my writing career. I was a second year undergraduate student at Makerere when I said I was writing a book. The other students laughed at me, pointing that only a few professors had been able to write a book. And you, a freshman at the University, you say you want to write a book.

I said, I can do it, a student can do it. I entered Makerere in July 1959. By December 1961, I had competed writing my first novel, years later published under the title, The River Between. In 1962, still a student, I wrote Weep Not Child, published in

1964. But I also wrote about 8 short stories. In addition I used to write weekly column for the Sunday Nation, titled, As I See It by James Ngugi.

It was also as a student that I wrote and directed the Play, The Black Hermit, the first English language play by an East African, to be played at the Kampala National Theater, which, until then, was dominated by European theater,

That has been my spirit, and I carried it into my post-graduate studies in Leeds University where I wrote and published my third Novel: A Grain of Wheat. That was the same spirit I carried back to Kenya on my eventual return from Leeds in 1968. There is more to tell about my days in Leeds in my memoir of Leeds under the title: Horseman of the Sixties. And I was punished for it.

It is not just me. In 19? Gacamba, a jua kali bicycle repairer, made an aeroplane, he termed KENYA ONE. It flew for ten minutes or so. You

would think that an African government would have come to his aid, and give him help to develop his skills? Instead, the Attorney General had Gacamba arrested and then warned never to fly an aeroplane without an aviation licence. Charles Njonjo is famous for swearing never to fly in an aeroplane piloted by an African.

What is the common thread in all those stories?

Rooted in ourselves, there is no height that we in Africa cannot reach, says An African Patriot. No, says a colonized parrot.

The Patriot and the Parrot: That is the struggle in Africa today. Unfortunately the Parrot has captured state power.

Take the example of the current leadership in Kenya. Ruto heard Trump talk of America First. Ruto echoed: Kenya First. Trump talked of the deep state-even though he was President Ruto talked of state capture: even though he was Vice-President and now President. Trump lies all

the time, smiling even. Truth and Lie are interchangeable. Ruto lies all the time, smiling. But now he has gone far is in his self-abasement: he has morphed into a mercenary of the West. He thinks he can sell Kenya to the West the way he used to sell chicken to Western tourists. We are not chickens, William Ruto.

Africa should read again the story Kweggir Aggrey of Ghana about the Eagle raised among chicken as a chicken. The farmer believes he has completely clipped the wings of the Eagle and that it believes itself a chicken. Eventually it discovers its wings. It raises the wings and flies...

"My people of Africa," said kweggir Aggrey, "we were created in the image of God, but men have made us think that we are chickens, and we still think we are; but we are eagles. Stretch forth your wings and fly! Don't be content with the food of chickens!"

The journey of self-belief must begin in a belief in our people and therefore the languages they speak: mother tongues.

Our languages are our wings to glory. Let us root ourselves in them and Africa will fly.



Advances in breast cancer screening allow healthcare professionals to diagnose breast cancer earlier. Finding the cancer earlier makes it much more likely that the cancer can be cured. Even when breast cancer can't be cured, many treatments exist to extend life. New discoveries in breast cancer research are helping healthcare professionals choose the most effective treatment plans.

Signs and symptoms of breast cancer may include:

A breast lump or thickened area of skin that feels different from the surrounding tissue. A nipple that looks flattened or turns inward.

Changes in the color of the breast skin. In people with white skin, the breast skin may look pink or red. In people with brown and Black skin, the

breast skin may look darker than the other skin on the chest or it may look red or purple. Change in the size, shape or appearance of a breast.

Changes to the skin over the breast, such as skin that looks dimpled or looks like an orange peel.

When to see a doctor

If you find a lump or other change in your breast, make an appointment with a doctor or other healthcare professional. Don't wait for your next mammogram to see if the change you found is breast cancer. Report any changes in your breasts even if a recent mammogram showed there was no breast cancer.

Causes

The exact cause of most breast cancers isn't known. Researchers have found things that increase the risk of breast cancer. These include hormones, lifestyle choices and things in the environment. But it's not clear why some people who don't have any factors get cancer, yet others with risk factors never do. It's likely that breast cancer happens through a complex interaction of your genetic makeup and the world around you.

Healthcare professionals know that breast cancer starts when something changes the DNA inside cells in the breast tissue. A cell's DNA holds the instructions that tell a cell what to do. In healthy cells, the DNA gives instructions to grow and multiply at a set rate.

The instructions tell the cells to die at a set time. In cancer cells, the DNA changes give different instructions. The changes tell the cancer cells to make many more cells quickly. Cancer cells can keep living when healthy cells would die. This causes too many cells.

The DNA changes that lead to breast cancer most often happen in the cells that line the milk ducts. These ducts are tubes designed to carry milk to the nipple. 



A new line of storms was barreling through Texas on Sunday as officials worked to assess damage from a series of tornadoes and severe weather which left at least 11 people dead overnight.

he attorney for a
17-year-old high
school senior charged in the daytime
shooting of San
Francisco 49ers
rookie receiver
Ricky Pearsall said

Tuesday that new video evidence supports his theory that the teenager should not be charged with attempted murder.

San Francisco Deputy Public Defender Bob Dunlap said after a pretrial hearing where the teen waived his right to a speedy trial that the evidence he found showed that what happened the afternoon of Aug. 31 at Union Square was an attempted robbery, not attempted murder.

He said the footage he has shared with prosecutors showed "it was a rather extended struggle" between the two, with Pearsall getting the better of the teen.

"It supports what's always been my belief and theory in this case, that this is an attempted robbery, not an attempted murder," Dunlap said.

Pearsall, 23, was walking alone to his car after shopping at luxury

stores in Union Square on Aug. 31 when the suspect allegedly saw the NFL player was wearing a Rolex watch and other expensive jewelry and tried to rob him at gunpoint, San Francisco police said.

A struggle ensued, and gunfire from the suspect's firearm struck both Pearsall and the teenager, who was shot in the arm, they said. The teen, who lives in Tracy, a city about 60 miles (100 kilometers) east of San Francisco, was arrested about a block away from where he allegedly confronted Pearsall.

San Francisco District Attorney Brooke Jenkins charged the teen last week with attempted murder, assault with a semiautomatic weapon and attempted second-degree robbery. Her office later added several gun-related charges.

Jenkins has not decided whether to try the juvenile as an adult and said her office needs time to investigate further and, if appropriate, petition the court to transfer the case to adult court. California law prevents prosecutors from charging a minor as an adult without judicial approval.

The 49ers rookie was shot through

the chest at close range, officials said. His mother, Erin Pearsall, posted on social media that the bullet went through the right side of her son's chest and out his back without striking any vital organs. Pearsall was released from the hospital a day later. Two days af-


ter the attempted robbery, he was

back at the team's facility.

He was at the team's season opener at Levi's Stadium Monday night when first responders who helped him after the shooting were honored and received signed jerseys from

Pearsall's shooting in an upscale shopping district downtown put the national spotlight again on a city that struggled with brazen shoplifting, empty storefronts and assaults on Asian-American seniors before voters choose a new mayor. Mayor London Breed, a Democrat, is in a tight reelection contest in November.

"Samuel Gizaw is a danger to our community," said Cheryl Huffman, Jayda's cousin.

Prosecutors say Gizaw retaliated after getting punched near the mall's food court, firing a shot toward a group of teen boys running away, as Woods-Johnson was hit by the bullet while walking with a friend.

Huffman says, on one hand, the family is pleased the judge decided to keep Gizaw's bail at \$2 million after his attorney asked for a reduction to \$790,000.

But they're disappointed the

judge is allowing Gizaw's family to use their home – valued at up to nearly \$1.1 million – as collateral.

Defense attorney Bryan Hershman asked for a property bond during last week's bail hearing.

"There will be at least two eyes on this young man at all times, more than that, four or six or eight eyes at all time to include mom and dad who have sort of created a shift for their own work so that one or the two of them can be home 24/7," said Hershman.

Under the court's ruling, if released, Gizaw is not allowed to leave home, except for medical or legal appointments.

"I think it was 24 people who wrote letters on behalf of Samuel, stating he's this outstanding child and that he is well-received in the community.


